2025 Call for Proposals

- Community-led pilot studies to test new **system alignment (SA) interventions** that improve health and wellbeing for communities experiencing **systemic racism**
- Led by a **community-based nonprofit, government agency, or tribal organization** that serves communities affected by systemic racism
- Engage all 3 types of systems: **medical, social, and public health**
- Evaluate the **feasibility and acceptability** of the system alignment (SA) intervention and its **potential** to improve health and wellbeing
- Engage people with **lived experience** of systemic racism in developing, refining, and testing the proposed SA intervention
- Partner with an **experienced researcher or research team** to assist with designing and conducting the pilot-test research activities

Pilot-Study Award Details

- Up to **\$200K** per study for pilot testing the SA intervention
- Up to **12 months** to conduct the study
- Up to **5 studies** selected for funding
- The CBO applicant organization may **allocate up to 50%** of the total project budget to a subcontract with the research partner
- Generate preliminary evidence necessary to pursue **future funding** for larger-scale research

Topic #1: Addressing Resource Inequities Across Systems

- Strategies for equitably allocating and sharing resources across medical, social, and public health systems in order to support collaborative solutions to systemic racism.
- Helping minority communities and minority-serving institutions secure equitable funding, staffing, and other resources needed to meet community needs.
- New financing mechanisms, payment models, staffing models, or other resource-sharing models that help medical, social, and public health systems work together to address forms of systemic racism.
- Solutions to "wrong pocket problems" that arise when the costs and benefits of collaborative work are distributed unevenly among medical, social, and public health system partners.

Topic #2: Strengthening the Voice and Authority of Marginalized Communities

- Strengthening the voice and influence of marginalized, racialized, and Indigenous communities in shaping how medical, social, and public health systems operate.
- Novel governance models, such as governing board representation and authority, novel community deliberation and decision-making mechanisms, such as participatory budgeting strategies, novel approaches to public reporting and disclosure requirements, and other innovative approaches to community oversight and accountability.
- Engaging people with lived experience related to systemic racism in developing solutions to systemic racism.
- Indigenous governance models and community-led decision-making processes that honor Indigenous values and practices.

Topic #3: Equitable Use of Decision Support Tools

- Novel decision support tools, technologies, policies, and practices that are designed to help medical, social, and public health system decisionmakers identify forms of systemic racism and work together to dismantle and disrupt these forms of racism.
- Novel data systems and algorithms that are designed to identify and flag possible instances of unjust racial patterning in the discretionary decisions of health and social system personnel
- Policies and practices designed to reduce the risk of implicit bias and discrimination when health and social system personnel make discretionary decisions.

Key Characteristics of Successful Proposals

- Engage **all three sectors**: medical care, public health, and social services.
- Clear & convincing logic model describing how the SA intervention will address health equity problems and address **systemic racism and inequities**.
- **Rigorous & relevant scientific approach** for pilot-testing the proposed SA intervention on a small scale and evaluating its acceptability, feasibility, and potential for impact.
- Clear description on how the lead-CBO applicant will work in partnership with an experienced research team to design and carry out the pilot research activities
- A commitment to **prioritizing community-initiated and community-engaged study approaches** by incorporating individuals with lived experience with systemic racism and individuals in all three sectors with expertise in approaches for dismantling systemic racism.
- A strong strategy for helping relevant audiences access and use study findings (**designing for dissemination**)
- Clear plan for how pilot-test results will be used to pursue **subsequent research opportunities** for further testing and evaluation of the SA intervention.

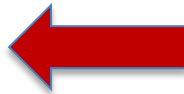
2025 Call for Proposals: Community-Led Systems Research to Address Systemic Racism

The Robert Wood Johnson Foundation released a new research funding opportunity through the Systems for Action Research Program on January 15th, 2025. This year's funding opportunity will provide research funding for community-led pilot-test studies that test the feasibility of new interventions designed to dismantle and disrupt forms of systemic racism through the alignment of medical, social, and public health systems. Pilot studies must be led by a community-based nonprofit, government agency, or tribal organization that serves communities affected by systemic racism, working in partnership with an experienced research team. Awards of up to \$200,000 each will fund pilot-test studies that can be completed over a 12-month period.

Proposals for this funding opportunity are due on **Wednesday, June 4, 2025, at 3pm ET**. Late submissions will not be accepted for any reason.

Systems for Action will conclude its operations as a RWJF research program in December 2026 and will not release another CFP before then. Pilot studies funded through this CFP are expected to help grantees prepare for and pursue future research opportunities from other funding sources beyond the S4A program.

SELECTION CRITERIA



- **Focus on Systemic Racism:** The application describes a form of systemic racism that has important implications for the health and wellbeing of populations residing within the U.S. and/or its territories. The application clearly describes the population groups affected by the systemic racism and the current state of scientific knowledge about the systemic racism, including important gaps in evidence and uncertainties.
- **Novel Systems Alignment Intervention:** The application describes a novel SA intervention designed to help representatives within social service systems, medical care systems, and public health systems work together to dismantle or disrupt forms of systemic racism. The SA intervention engages representatives from all three types of systems. A clear theory of change is described for how the SA intervention is expected to improve health and health equity for population groups that experience systemic racism. The SA intervention has the potential to be adapted, scaled, and spread to other communities and settings, if successful, to achieve broad national impact.
- **Evaluating Acceptability, Feasibility and Potential for Impact:** The application describes a rigorous and relevant approach for pilot-testing the proposed SA intervention on a small scale and evaluating its acceptability, feasibility, and potential for improving health and wellbeing for communities that experience systemic racism.

How to Apply

First, download the Funding Opportunity Brochure above and read it in its entirety. In the funding brochure you will find eligibility requirements, background on systems alignment research, what types of questions we are interested in funding, and information on what will constitute a strong proposal.

Next, download the Proposal Narrative Template and Budget Narrative Template (linked below). The Proposal Narrative Template provides suggested lengths for the sections of the proposal and what information we expect to see in each section. Both templates are also found in the RWJF application portal.

Finally, all applications for this solicitation must be submitted via the RWJF online system. Visit www.rwjf.org/cfp/S4A8 and use the "Apply Online" link.

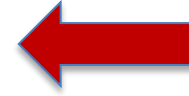

1. Systemic Racism Focus:

- Describe the specific form(s) of systemic racism your proposed research study will address, including the population group(s) affected by this racism.
- Describe how this systemic racism operates within or affects medical, social and public health systems.
- Briefly summarize the current state of scientific knowledge about this form of systemic racism and its connection to medical, social and public health systems, noting important gaps in evidence that your proposed research will address.
- We recommend devoting up to 2-3 pages to this section.

2. Novel Systems Alignment Intervention:

- Describe your proposed system alignment (SA) intervention for helping representatives within social service systems, medical care systems, and public health systems work together to dismantle or disrupt the form(s) of systemic racism described in Section 1. Your SA intervention must engage representatives from all three types of systems. See the S4A program's [FAQ page](#) for more information about how these systems are defined, including delivery systems and financing systems.
- Describe your theory of change or logic model for how the SA intervention is expected to dismantle, disrupt or remedy the health effects of the chosen form of systemic racism.
Include any references to scientific evidence and/or practical/lived experience that support



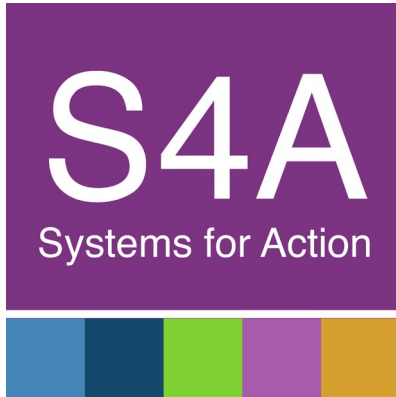
- For the purposes of this CFP, CBOs eligible to serve as applicant organizations include Section 501(c)(3) charitable organizations, local and state government agencies, and tribal organizations.
- Preference will be given to applicants that are either public entities or nonprofit organizations that are tax-exempt under Section 501(c)(3) of the Internal Revenue Code and are not private foundations or Type III supporting organizations. RWJF may require additional documentation.
- Applicant organizations must be based in the United States or its territories.
- If necessary, the applicant organization may utilize the services of a fiscal sponsor to support the project's financial management and grants management and reporting activities. The fiscal sponsor can be the research partner that the CBO has partnered with in this proposal.
